TERMS AND CONDITIONS:

1. Condemned unserviceable store items (Instruments), pertaining G&RB of SOI as given in **Appendix "A"** will be sold out on **"As is where is, basis"** to the highest offered bidder through electronic tender cum auction.
2. The required manpower for lifting the auctioned items to be arranged by the bidder himself at his cost.
3. The interested bidders will have to send the DD/BG only to tune of **Rs 25,000/-** as security/EMD in favour of **Establish & Account Officer, G&RB, Survey of India** payable at **Dehradun** to the following address:

- EMD shall reach above address before the date of opening of the technical bid otherwise the bid will be considered as nonresponsive. EMD should remain valid for a period of 120 Days. The EMD will be refunded to the unsuccessful bidder except **first and second highest bidder after live e-Auction.**
4. The Condemned Instruments can be inspected on any working day between 10.00 am to 4.00 pm in the premises of G&RB with prior intimation to office authorities.
 5. The entire sale/bid value with applicable taxes shall be deposited by the highest bidder within 10 days from the date of issue of sale letter. The sale / bid value shall be deposited in the form of Demand draft/pay order, drawn on any of the commercial bank in favour of Establishment & Account Officer, Geodetic & Research Branch, Survey of India, payable at Dehradun
 6. The possession of Condemned Instruments will be given to highest bidder on the receipt of full amount of bid value after completing all the formalities.
 7. The highest bidder/purchaser will have to remove the Condemned Instruments **within 10 working days** at their own cost from the date of issue of sale letter to the highest bidder.
 8. In case if the highest bidder does not lift the condemned instruments within 10 working days, the bid security/EMD deposited by him shall be forfeited without any communication. Thereafter, condemned instrument will be offered to the second highest bidder at the price offered by highest acceptable bidder.
 9. The highest bidder will have to deposit GST @18% or RATE as applicable on the entire auctioned amount with the concerned authority and the deposit slip shall be submitted in the G&RB before seeking for gate pass to lift the Condemned Instruments. Bids should remain valid for acceptance for a period of 90 days from the date of opening of the technical bids.

10. In case of any dispute arises relating to any aspects of this contract between two parties, the decision of the Director, G&RB shall be final and binding on the successful/highest bidder.
11. In case the date of opening of bid is declared as a holiday on any account, the opening will be taken place on the next working day.
12. Entire items will be disposed of in one lot.
13. The seller / Auctioneer reserves the rights to accept or reject the highest bid after assigning the reason and the Contract of any or all the lots may be allotted by the seller /Auctioneer to one or more than one bidder as seller/Auctioneer may deem fit and no claim /complaint in this regard will be entertained by the seller / Auctioneer.
14. Bidders must submit a notarized copy of the valid registration certificates issued by the State (or Union Territory) Pollution Control Board (SPCB) and produce it at the time of taking delivery of the materials, failing which their bid will be liable for rejection. In case of lead acid batteries, used/waste oils and nonferrous metal wastes, in addition to submitting necessary valid registration from the SPCB, the bidder must also submit a notarized copy of the valid registration certificate from CPCB (or MoEF); and e) In case of a sale involving inter-state movement of goods, the buyer shall also submit an NOC from the concerned SPCB, with whom the buyer is registered, to the seller before taking delivery, failing which the buyer will be responsible for the consequences and the seller shall take further decision as may be deemed fit.
15. The bidders are requested to refer the detailed instructions for online bid submission in the GeM Portal.
16. The G&RB reserve the rights to cancel the e-tender cum auction bids without assigning any reason there on.
17. Tender cum auction Process:

The Selection will be done in three stages given as under:

(i) Technical Bid: Following documents to be uploaded on the portal for technical bid

- a. EMD
- b. GST registration certificate.
- c. Tender-cum-Auction acceptance letter (**Annexure-B**)
- d. Undertaking for non-blacklisting firm and non-registration of criminal case (**Annexure-C**).
- e. Scanned copy of last three years ITR of the firm.
- f. Scanned copy of undertaking that the firm will not sublet/transfer the contract to any other firm.
- g. Undertaking for Disposal of e-waste / hazardous waste (**Annexure-D**).
- h. Copy of registration and authorization for disposal of e-waste issued by the pollution control board or other authority.

Above documents of all bidders will be scrutinized for their qualification in next stage.

(ii) Financial BID:-

1. The financial bid shall be filled on-line as per GeM. The offline financial bids will not be accepted.
2. E-auction relating to GeM portal will be done through the portal as per scheduled date and time. The start price of the auction will be the price offered by H1 bidder in financial bid. After completion of auction, final H1 bidder will be declared.
